## Stop Payment of Unauthorized Withdrawal

**\* AN UNAUTHORIZED Withdrawal MEANS:** 1) An electronic fund transfer from a consumer's account initiated by a person, which was not authorized by the consumer in writing to initiate the transfer. 2) An electronic fund transfer in an amount greater than that authorized by the consumer. 3) An electronic fund transfer that is debited from the consumer's account earlier than that authorized by the consumer. 4) An electronic fund transfer that is debited from the consumer's account after the consumer had revoked their authorization. An unauthorized withdrawal does not include an electronic fund transfer initiated with fraudulent intent by consumer or any person acting in concert with the consumer.
